





# Cookie Policy

### What are cookies?

Qibbel uses cookies. Cookies are small text files placed by websites on your device (such as a computer or smartphone) to collect information about your browsing behavior and preferences. There are different types of cookies:

### a. Functional Cookies

We use functional cookies to provide an optimal user experience when visiting our website. These cookies are also necessary for the proper technical functioning of our website.

## b. Analytical Cookies

We use analytical cookies to gain insights into the information needs and interests of our visitors. For example, information about the number of visitors or the most visited pages. We use this information to optimize our website. We do not store any personal data in this process. These cookies cannot be used to identify individual actions taken by you on the website.

### Google Analytics

For website analysis, we utilize the services of Google (Google Analytics). Qibbel has entered into an agreement with Google. Google may provide this information to third parties if legally obligated to do so, or if third parties process the information on behalf of Google. We have no control over this. We have not allowed Google to use the obtained analytics information for other Google services. The information collected by Google is anonymized, and your IP address is explicitly not provided. For the cookies placed by Google and the potential data they collect, we refer to the statements in Google's Privacy Policy. Please note that these statements may change periodically.

### c. Marketing Cookies

To reach our specific target audience, we use tracking cookies. These cookies collect anonymous data about users' browsing behavior. Based on this information, Qibbel can display targeted advertisements to people who have visited certain pages of the website or exclude them from advertisements. Our tracking services include Facebook custom audience and Facebook impressions.







#### Social media

We use cookies from Facebook to enable sharing content from our website. For the cookies placed by Facebook and the data they collect, we refer to the statement on <u>Facebook's website</u>. Please note that these statements may change periodically. Qibbel's website has no control over this.

## **Managing Cookies**

You can manage your cookie preferences through the cookie settings on our website. You can choose to accept all cookies, only accept functional and analytical cookies, or reject all cookies. However, please note that rejecting cookies may limit the functionality of the website.

## Who is responsible for processing your data?

Qibbel, located at Haven 1, 2921 AA - Krimpen aan den IJssel, is responsible for processing data as described in this cookie policy. This cookie policy applies to qibbel.nl.

## **Browser Settings**
